

Another year has almost come and gone at time of writing this report.

We were certainly tested with the 2023 Wet Season, particularly our businesses that services the Gulf Community, with almost record Road Closures with flooding in the Gulf Rivers.

We have made improvements to several of our businesses to help us deal with extreme weather events like this, in the future.

The new supermarket in Normanton is a credit to everyone associated with it. It is going better than what we originally predicted it would, financially and is a major coup for GREAT to have built and operate.

The shop looks excellent particularly with artwork out the front, this artwork was designed by local Gulf artists Cathy Snow and Kelly Barclay and painted by Ian Waldren and an offsider.

There are plans afoot to upgrade the Doomadgee Roadhouse once we finalize our leasing arrangements with Doomadgee Shire Council.

We assisted Gununamanda store on Mornington Island this past year, they are now operating under their own steam. We assisted and funded a Car Hire business on Mornington Island, this has been operating for several months now. A fair bit of my time has been spent lobbying Government, this year, particularly with upcoming referendum regarding the Voice.

This lobbying and media has also lifted our profile significantly with Industries and Governments.

Unfortunately, we lost a dear friend and colleague this year.

Mr. Ned was a long time Director of ADBT and a founding Director of GREAT. He was the Mayor of Doomadgee and an extremely capable Entrepreneur in his private life.

He will be greatly missed around our Board table and in Doomadgee and Northwest Queensland. In ending I thank my fellow Directors for their ongoing support and their hard work.

I thank Brian Arnold our CEO and all staff and contractors for their hard work this year, these guys are the engine room of our organization, and we would be buggered without them.

The Hologram Theatre featuring local Indigenous guide Mr Jaun Walker. The attraction is the first permanent hologram display in the world!



Section 3: Economic & Business Development

Online Casino Gaming License

The GM and Chairman met with Mr Michael Healy MP and his advisor Richie Bates. Mr Healy asked us to provide a letter requesting a license.

The GM received a response from the letter sent to Michael Healy's office. It triggered a meeting with Anthony Crack, Executive Director, Office of Liquor and Gaming Regulation and Craig Turner, General Manager, Licensing. This regulatory body is State and really not appropriate for the license we were seeking, regardless the GM attended the meeting which lasted around 35 minutes. Both men put their opinions forward and I was allowed to do the same but there was no value to the meeting at all. Both Michael Healy and his Advisor Richie Bates have been really nice and have made an effort to help us.

The GM then wrote a letter to Dr Jim Chalmers, the Treasurer. The letter was very similar to the one written for Mr Healy.

The GM and Tim Wright from the Greenbank RSL have used that letter to request a meeting with him during the week of the 26th of September while the Chairman, Business Advisor and GM are in Brisbane. There was NO response from Chalmers office.

The GM has engaged Katja Gibson, the former Chief of Staff for Bob Katter to manage a regular media campaign to help lift the profile of GREAT/ADBT and its directors. It's hoped through newspaper articles and maybe TV interviews the importance of an organisation like GREAT/ADBT to aboriginal people can be acknowledged. Once acknowledged we'd hope that recognition would bring Ministers and high-level government officials to us as they seek answers to the many issues aboriginal people face today.

The online casino license is part of the "end game" associated with lifting our organisation in the media and ultimately govt.


Eventually an online casino license/s will be granted to an Australian company, likely Aristocrat Gaming. At that point we have the option to sue the government for racial discrimination.

Gununamanda Store

The GM and chairman had been contacted by Kyle Yanner to provide some assistance with the management of the Gununamanda Grocery store. It was trading while insolvent. Below are the resolutions that have been passed by the Gununamanda board.

Board Resolutions

1. As per our financial situation it is in the best interests for the Gununamanda Board to release the Store's current General Manager from the position subject to obtaining legal advice.



3. The State Govt meet with the GREAT and Gununamanda Board to do a true audit of all accounts.

To assist the Gununamanda board, the board allocated up to \$15,000 over a 30-day period to place a temporary manager and to send our grocery expert, Mr Nigel Tillett to assess the operational situation.

Ultimately, the GM believed the Gununamanda board would like GREAT to oversee the management of the store but at the time there was over \$1 million owed to creditors.

The GM continued to supply manager/s for the Gununamanda Store to keep the doors open. Working capital can be very low at times but due to the skill of our managers they held their own.

Managers, Glenn Smith and Assistant Manager Michelle Baker basically turned the store around and were commended for the work they had done.

The GM moved Glenn Smith from Gununamanda to the DRH to allow Paul Jones to finish as he resigned in November. The GM hired 2 asstant managers, one for Gununamanda and the other for the Doomadgee Roadhouse.

The GM continued to liaise with the managers he put in place. Michelle Baker, Assistant Manager Liz Hanakowski and prior to Michelle's arrival Glenn Smith did a great job! Collectively those three people saved Gunanamanda. There is still a long way to go but things couldn't be going better.

A new managing couple have been hired. Michelle Baker was employed as our Assistant Manager at Normanton Foodworks on the 1st of July.

Meeting with the Department of Agriculture, Fisheries & Forestry (DAFF)

The GM met with Peter Timson, First Assistant Secretary, Jessica Buckley, Director – Compliance and Enforcement Division.

The GM took part in a survey on the appropriateness and effectiveness of high-level DAFF staff engaging with people on the ground making things actually happen. After the survey the GM didn't hear anything from DAFF or the survey results.

While a great idea the GM believes they will struggle to be relevant beyond just sending notifications of grants etc.

DAFF stopped by one last time as part of their continued effort to leave Canberra and get out into the real world. The GM updated the trio on all GREAT/ADBT projects. They seem to only offer information on available grants which is available everywhere. I have suggested they pick projects and get directly involved w money and their expertise, basically have some skin in the game, get immersed in what is going on. But I have been saying that to government departments for decades with no joy.



Bush Pigs - Feralizer (Burketown)

This is a great project idea for our region. The Chair, GM and BA met with White Box on the 27th of September in Brisbane. White Box is managing the development of the Feraliser system in Coen. This project has grown to include following features:

- Feralizer. Pig carcasses used to, after a process, enrich soils to reduce fertiliser use. Grow crops.
- Field shot pigs for export to Germany due to sanctions against Russia
- Field shot pigs collected as part of a safari. Employment for Indigenous guides.
- Farming wild pigs in an eco-shelter for human consumption (5 STAR restaurants, domestically and internationally)
- Eventual establishment of terrestrial and portable abattoirs to process pigs and cattle

The GM believes there are a number of activities associated with the control, management and monetizing of feral pigs. He also believes it is one of the most important economic development projects he has seen in his 30 years in economic development.

This project was presented to the DAFF as a way to get immersed in a project but they didn't seem to get it and/or find interest.

Normanton Foodworks Roadhouse and Grocery (Grocery Complex)

Key milestones with the construction of the complex listed below.

- 1. Staff duplex went to lock-up stage and we started ordering furnishings
- 2. The original date Ergon was to upgrade the power was the 21st of November which was far later than our completion date. The GM rang Craig Crawford's office to see if he could influence an earlier date. As Craig is the Minister for DATSIP, he was able to get them to encourage Ergon to establish the power sooner. Subsequently Ergon people were in town the week of the 12th to the 16th of September.



- 3. Fit-out of the store was scheduled in mid-October.
- 4. The community opening on the 22nd of November was a huge success! Attendees of note besides the ADBT/GREAT board and staff were:

Foodworks Normanton is owned equally by Aboriginal organisation Bynoe Community Advancement Cooperative Society (CACS) and the Gulf Regional Economic Aboriginal Trust (CREAT). Recognising the need to improve store operations Foodworks Normanton were able to understand the immediate benefits ESL's could bring to tilute store and had no hesitation in contacting OZESL to bring that to life.



Once the digital ticketing was installed the State Manager from Foodworks, Wayne Mason stated that the Normanton Foodworks store is the most advanced in the country!

Daintree Discovery Centre

The Daintree Discovery Centre as we came out of COVID became extremely busy! The all-time daily takings record has been surpassed several times over the last few weeks. By the end of this financial year the Daintree Discovery Centre had a record nett profit.

The GM organised the purchase of a new vehicle for the Manager, Abi.



The GM bought a new robust trailer. The other trailer had become dangerous. The trailer will be used by the centre for dump runs etc and the GM to transport bottled water. It can also be used to transport stock to Normanton Traders from time to time.

Developments

1. Indigenous Content

For the time being, the hologram room incorporating a presentation by Juan Walker is a very good start to including as much indigenous content as we can. The presentation by Juan Walker is the first hologram story.

Disabled ramp leading to the Hologram room started construction in March.

2. Jurassic Bottled Water

The DDC now has 1.5 litre bottles in addition to 600ml. Production for 600ml and 1.5l has been completed using the updated label.

3. Concrete Wall to be added under the main entry building

The concrete embankment has been postponed until next financial year as the priority remained with Hologram Room.

4. Repair of the Interpretive Centre Roof

While the builder was on site, we got him to fix the roof which had been damaged by the tree loppers. There were also some rotten boards that were replaced.



5. Repair of the house that will transition to the Hologram Attraction

The house had deteriorated quite a bit over the last 30 years but its re-purpose has saved us hundreds of thousands of dollars. Most of the repairs had centred around decks, floor joists and a section of roof. The repairs have been painted or oiled to ensure a long life.



Ancient Journeys

The GM advertised on Seek for a sales assistant, basically an Indigenous person to be behind the counter. Preferably someone who has been working in the art sector and may be an artist themselves.

Through family connections within the Gulf region a person was found and we reopening in October. She has connections to Mornington Island and the Northern Territory. AJ remained open for several months opening from 9am – 2pm Monday thru Friday.



The person was going really well but didn't come back after Christmas.

The store has been restocked and the Reckon accounting system updated as we waited to find another assistant.

By chance the GM met another Indigenous person with connections to Mornington Island. She started in February and was employed as the Art & Retail Development Manager. She is an artist and is well connected to the Lower Gulf and Indigenous people across Australia. She will be participating in the Cairns Indigenous Art Fair (CIAF) on behalf of Ancient Journeys in July. She is currently expanding stock and adding a range of clothing.

Section 4: Operations

Office next to Ancient Journeys

Further to the board resolution to investigate and make an offer to purchase the shop/proposed office next to Ancient Journeys. The GM sought a market valuation on the property. In the past the shop has been for sale for \$400k (firm). Based on the market valuation the GM made a firm offer but the owner did not accept.

The shop/proposed office would have been used for GREAT staff and board meetings.



Social Enterprise World Forum

As the Gulf Regional Economic Aboriginal Trust (GREAT) is one of the largest and most successful social enterprises in Australia, the GM decided that he, the Chairman and the Business Advisor should attend the event. The BA was successful with a grant of \$3000 to supplement the costs associated with attending.

This two-day hybrid event (28 & 29 September) included 100+ speakers and 55 sessions over five stages, and is set to be Australia's largest gathering of purpose-driven individuals in 2022.

The extensive program included inspiring keynotes from Australian of the Year Dylan Alcott AO, climate activist India Miro Logan-Riley, Daniel Flynn, cofounder of Thank you, and Kate Raworth, author of Doughnut Economics, as well as masterclasses, No Filter talks, unconference sessions and fireside chats.

Business Advisory, Development and Loan Activity

Security at the Doomadgee Roadhouse

To date, ADBT has provided our client with a license, a control room with monitors that are connected to cameras throughout the roadhouse compound. The GM has also promised him further support in the way of loans and coordination of his services if he can gain a contract with one of the organisations within the community.

Dwayne Pott and his team continue to work for the Doomadgee Roadhouse. 70 hours a week which we look for clients needing security services.

Charter Boat Hire

A 9m 2x 250HP charter boat with centre console and toilet. It is suitable for day trips only and registered to travel up to 30 nautical miles off the coast. 400 litre tank and has a capacity of taking 6 passengers and 2 crew per trip. Boat is fitted with fridges. A coxswain license is required to operate this boat.



The proposal would require joint funding with say a bank/IBA to proceed since as the loan amount required is not within the scope

of ADBT funding. This did not proceed.

Lease of a Hotel

The Business Advisor assisted a couple who were interested in securing the lease of a hotel. Unfortunately, the lease negotiation was unsuccessful. The lease arrangements were considered unreasonable and insisted that the lessee would be responsible for all maintenance and repairs including all contents, building and structures.

Online Clothing Concept

The Business Advisor worked with a client on a business proposal (e-commerce) to provide modern clothing both online and from her home to the locals and tourists.

Car Hire

A client contacted the Business Advisor about the establishment of a car hire business based on Mornington Island. The business case was established and looked promising. Ultimately funding was approved.



- Website was established. To book a hire car on Mornington Island visit www.morningtonislandcarhire.com.au
- Company has been set up. The client acts as a sole director and Business Advisor acts as the Company Secretary.
- There are 3 cars available for hire.
- The cars are being leased to the client.

Cattle Property Purchase

A member of a Traditional Owner Group was interested in leasing a property and eventually buying the land.

GREAT agreed to fund stage one of the feasibility for this project provided ILSC will fund stage 2.

The client's Business Advisor and a consultanthas been sourced to undertake a feasibility study for a proposed Butchery, Abattoir and Market Herd to provide meat products to a region.

The Traditional Owner Group would consider leasing land to the client once the land has been acquired.

Cultural Awareness Training Business

The Business Advisor provided assistance with developing a promotional brochure. The graphic design and first print run were funded with ADBT business support funding.

Lease/Purchase of a Water Truck

The Business Advisor assisted a client to assess the lease/purchase of a water truck for road works in the gulf.

Lawn Mowing Business

The Business Advisor has assisted the client to start the business. The business is now running in the community of Doomadgee. Support has included:

- Costing and invoicing
- Arranged business insurance cover due to contracts with govt agencies. ADBT funded the firstyear premiums through its business support program.
- A loan was approved to buy lawn mowers and other equipment

Bidunggu - Water Truck

The Bidunggu water truck was being dryhired to New Century Zinc from October-December.

The truck has been parked at Bidunggu Community and a community person continues looks after it. Recently some profits were used to make some changes/repairs to Bidunggu homes.

Cathy Snow

The ADBT once again supported Cathy Snow to attend CIAF. She was very successful selling almost all of her 28 paintings.

The GM has organised limited edition prints for Cathy Snow. Like Kelly Barclay she created a mark to stamp into the prints as another level of authenticity. The mark is based on one her mother wore, a very special aspect to her prints.



10 prints have been stamped, signed, titled and numbered. They are available at Ancient Journeys and have been added to the Ancient Journeys website.

Cathy's prints have been featured on a wall in Ancient Journeys.



Kelly Barclay Prints

Kelly Barclay was also very successful at CIAF!

The GM has organised the printing of 4 more prints for Kelly, each has been framed and 2 special displays created.



All of Kelly's prints are available in store and on the Ancient Journeys website.

Grant Applications Submitted

Indigenous Land and Sea Corporation (ILSC) Grant - Normanton Foodworks

\$2M grant application for the Normanton Foodworks. Outcome of funding was successful.

After much deliberation ILSC grant for \$2M was finalized and approved.



NIAA Food Security Funding Application

An application was completed and submitted to NIAA Food Security Funding Application for \$500k for fit out Normanton Supermarket.

GREAT on behalf Normanton Foodworks was successful and received funding of \$483k grant funding towards internal fit out.



Healthy Eating/Food Security Program

The Business Advisor has been working with Queensland Health on this program. This activity was an integral part of our Food Security Grant for NIAA.

Basically, it involved the following:

- Need to have some base line statistics to show the social value of the project at the outset
- Need to have a mechanism for demonstrating competitive pricing of food for our store when compared to regional/metropolitan Queensland
- Health promotion strategies for healthy cooking and eating
- Regular events by Health and Well Being Queensland to demonstrate healthy cooking/preparation

NIAA Grant for Solar (Normanton)

GREAT on behalf of Normanton Foodworks was successful with a grant for \$100,000 for a 100kw solar system.



NIAA Grant - Seisia

The Business Advisor completed and submitted a similar application to ours for Seisia Community Torres Strait Islander Corporation.

This submission for \$500k was also successful. Seisia have received funds and are in the process of upgrading refrigeration, purchasing vehicles, and undertaking staff training.

Australian Trade and Investment Commission Grant - Seisia Holiday Park

The Business Advisor assisted Seisia Holiday Park to upgrade its camping facilities by applying for a \$89k grant to purchase and install 5 quality Glamping tents in their caravan park. Total cost to purchase and install tents was estimated at \$178k. The submission was successful with a 1:1 funding submission.

Grant Funding (Indigenous Visual Art Industry Program) - Ancient Journeys Expansion

The Business Advisor submitted an application for expansion of Ancient Journeys shop by purchasing the shop next door.



Image above. \$500k in grant funding was sought with ADBT contributing an additional \$250k towards the purchase/project.
Proposal is as follows:

- Establishment of an Indigenous Wearable Art Retail Hub (111m2) in the central Cairns CBD.
- Ancient Journeys First Nations
 Fashion will be the only retail outlet outside of the metropolitan centres in Australia and will be located adjacent to our Ancient Journeys
- Existing shop is 172m2 and is insufficient in size to accommodate Fashion Shop
- Ancient Journeys First Nations
 Fashion Hub will display and
 promote only Indigenous wearable
 Art
- Ancient Journeys First Nations
 Fashion will feature established and
 well known Indigenous wearable art
 from outlets like Jarawee, Ilkunti,
 Magpie Goose and Brosiscus as well
 as other Indigenous Artists from all
 over Australia and in particularly
 artists from the lower Gulf and Cape
 York communities of Queensland.

This grant application was unsuccessful.



Daintree Discovery Centre - State Govt Grant

State Government Grant application for \$20k was successful for plant and equipment to improve disability accessibility by:

- 1. Installing a 360 virtual reality (VR) experience in our Interpretative Centre located on site. People with a disability will be able to access all the sites by using our virtual reality headsets.
- 2. Installing a remote-control live feed camera at the top of our 23-metre-high canopy tower. This will allow access to a camera located at the top of our tower and provide 360-degree view. The camera direction will be controlled by the visitor located at the base of the tower.
- 3. By providing 360 VR to the sites of the Daintree tour and Live feed from our Tower, it is envisaged we will increase tourism number.

Business Opportunities

Indigenous Land and Sea Corporation (ILSC) - Normanton Enterprises

The CEO and the Business Advisor have met with our new Project Officer Graham Fagan and outlined possible projects for funding: These included:

- Mobile Abattoir/small stand alone
- A Food Works building
- Feraliser
- Feral pig as a food for domestic consumption
- Establishing an improved breed from feral pigs with the view of producing a quality pork for domestic consumption
- Burketown Grocery Store

Mobile Abattoir Proposal

The Business Advisor created a Business Model incorporating a mobile abattoir consisting of 3 parts: 1. Mobile Abattoir/MPU- processes cow to carcass on site. \$750k

- 2. RV- Transport carcass to Hub
- 3. Hub- Process carcass for distribution-\$700k

Purchase of Another Foodworks Store



The Business Advisor investigated purchasing another Foodworks store. Although this business venture yielded high returns and cashflow (25% ROI and \$540k net profit) it was decided to withdraw from this purchase since risk was regarded to be too high with Normanton Supermarket coming online and the possibility of supporting Gunanamanda Store. We have left the door open to resume negotiation in the future if the store is still available.

Normanton Foodworks Bakery

The Business Advisor has prepared a proposal to establish a bakery that will be added to the existing Normanton Foodworks store. The following features have been decided:

- Area currently used for white goods will be repurposed to house the bakery
- A ¾ wall will close off the bakery from the grocery area
- The wall facing the café area (table and chairs) will be opened up from wall to wall and display cabinets put in place.

- Bakery will cook bread and a vast number of other bakery goods for example, cookies, muffins, a variety of breads
- Existing kitchen will be closed off and used to cook hot foods that will supplement the bakeries offerings ie pies, sausage rolls, individual meals, chickens, breakfast rolls and etc.
- Coffee will be served from the bakery, maybe to machines
- Likely two registers
- Ovens will be powered by electricity
- Loaf bread will only be available in store not via the bakery.

It is envisaged that the bakery will open April/May 2024.

Burketown Store

The Business Advisor has completed a review of the Burketown Store for purchase/loan by a social enterprise owned by the Burketown community.

- The purchase would be funded through a contribution from Moungabi, a loan and grant from ADBT Store would be reconfigured to combine it with Nowland's Engineering. The existing checkouts would be combined at the store and the Nowland's checkout be repurposed.
- ADBT/GREAT would provide coordination of ordering through Foodworks on a wholesale basis
- ADBT/GREAT would provide an accounting and bookkeeping service

Below is an image of the Burketown Store before any reconfiguration.



Abbott Street Building

The Business Advisor assisted the CEO with the valuation and viability of the commercial premises. If purchased the building would have been developed in the following manner:

- Office space for ADBT/GREAT
- Office space for other indigenous organisations from the Lower Gulf
- Office space for other indigenous organisations that would be viewed as having similar goals and interests

The CEO believed that it would take between 1 to 2 years to fully tenant the building. Considering the current market, those involved felt it was overpriced.

Conferences

Social Enterprise World Forum - Brisbane 28-29 September 2022

The Chairman, Business Advisor and CEO attended the conference. White Box Enterprises provided bursaries for the three of us to attend.

Points of interest from the conference were as follows:

- 1. Met with White Box to discuss Feraliser project. In summary this project is about harvesting feral pigs and processing them into a bio-stimulant suitable for crops. Bio-stimulants can be sold for around \$5 a litre. Bio-Stimulant improves plant efficiency for nutrients and stress while fertilizer improves quality of soil. Bio-Stimulants should reduce fertilizer use and lead to higher yields. Feraliser Project is a joint venture between Kalan Enterprises and White Box and GREAT is seeking to become a partner in this venture.
- 2. Met with Cissy Gore Birch from the Indigenous Carbon Industry Network (ICIN) and Viktor Steffensen from Firesticks to discuss savanna burning and carbon credits. This may be something GREAT may want to consider.
- 3. Opportunity to strengthen our relationship with ILSC since we have some more projects in the pipeline with ILSC.

Remuneration of GREAT/ADBT Board Directors Cash Compensation

Fees for Serving on the Board

For in-person Board or committee meetings, each Director in attendance shall receive \$650 per day. This includes the Chairman.

Compensation for additional days before and after meetings. It was resolved that the Board would compensate Directors whose travel is disrupted/extended at a rate of \$250 per day and when loss of wages isn't appropriate.

Board Directors will receive \$500 a day when attending a special event, meeting or investigation.

Board Directors will receive \$100 a day while attending business forum; \$300 per day if they are a speaker.

Incentive Payment for Directors

An incentive payment of up to \$6,000 annually will be paid to each Director in December of each year that meets the incentive payment criteria.

The incentive payment criteria shall be determined by the Board each year. For the 2017 calendar year, the incentive payment criteria will include:

- 1. Attendance at four out of six Board meetings for the year.
- If a Board member is unable to attend a meeting, the GM must be notified of an apology with at least one weeks notice prior to the meeting. The reason for the non-attendance should be stated.
- 3. The Director should attend one business or organisational visitation or familiarisation.
- 4. The ADBT will pro-rata a Director's incentive payment if a Board Director is removed prior to the end of the calendar year.

Penalty if a Board Director Leaves a Meeting


If a director leaves the meeting for more than one hour and without a valid excuse, the Director will be charged an hourly rate or \$81.25 an hour or the equivalent of dividing the day rate of \$650 by eight hours.

Retainer for Serving as Chairperson

A monthly retainer shall be paid to a Director who serves as Chairperson. The retainer shall be payable in arrears in monthly payments on the last Friday of the month in the amount of \$2,000.


Travel Expenses



The largest source of income continues to be business development funding provided under the GCA. Funding is likely to continue for the foreseeable future following the sale of Century Mine to New Century Resources Limited (NCZ) in 2017, and most recently in 2023 the acquisition by Sibanye Stillwater of the New Century zinc mine tailings project in Queensland's North West Minerals.

Interest is earned on deposits held by the Trust and on loans extended to business clients. Investments managed by Morgan Stanley were transferred to GREAT in 2022, with the remaining investment to be transferred from ADBT to GREAT in 2024.

Dividend and investment income were lower in 2023, as a result of investments being transferred to GREAT in 2022.

The Board continues to investigate investment opportunities that are ultimately aimed at replacing the GCA income to enable the ADBT to provide business development and facilitation services in the long term.
